Sir,

This is to inform that inspite of repeated reminders you have failed to supply the pre-production supply of 5 Nos. of Carbon Ribbon. As per the terms and conditions of the Purchase Order the delivery date for submission of Pre-Production sample was 24.11.2018 and the remaining supply to be completed on or before 15.01.2019. You are supplied pre-production supply twice but the same was unsuitable for our use. However, the sample supplied by you on 12.02.2019 was found to be suitable for our use, but vide e-mail dated 21 February 2019 you were shown the inability to supply the material.

2. ISP had again vide letter dated 05 Mar 2019 requested you to supply the material exactly as per tender requirement but you have not supplied the material. Therefore, ISP has issued show cause notice on 04 April 2019 and requested to submit the explanation as why the following sanctions besides any administrative action including ban and black-listing not taken against you

(a) Forfeiture of EMD (b) Termination of the contract for default.

3. It is regretted to inform that till date, you have not supplied the material nor submitted the explanation to our show-cause notice thereby your firm has wasted considerable amount of time of this office.

4. In view of the above, ISP Purchase Order No. 4500015959 dated 02.11.2018, is hereby stands cancelled and no supplies will be solicited against the same. Also the EMD amounting Rs. 8,500/- submitted by you against above referred tender will be forfeited to SPMCIL Account.


