With reference to above subject it is to informed that Security Paper Mill, Hoshangabad had issued Show cause notice vide letter no. 20(Magnetic ST)/2015-16/405 Dated: 30.10.2015 to M/s Aristocraft International Pvt Ltd., New Delhi.

M/s Aristocraft International Pvt Ltd., New Delhi had submitted the reply to show cause notice vide letter dated: 13-11-2015. But, the reply is found to be the same, which was submitted by the M/s Aristocraft International Pvt. Ltd. before the Arbitral Tribunal for which the claim was made. All these things are mentioned in the facts of the award dated 10.10.2014 and the same was repeated in the reply and hence not found satisfactory. The Tribunal has already directed for taking action by following provisions of Procurement Manual Code of the Ethics and General Conditions of the Contract and by following the same it is to inform that M/s Aristocraft International Pvt Ltd., New Delhi has been banned for four years from the date of opening the tender i.e. from 10-04-2012 to 09-04-2016.
